**“READ ALOUD” PROJECT WITH THE SHACK NEIGHBORHOOD HOUSE WAS A**

**SUCCESS:** Mike Attfield, Nicole Bode, Susan Brown, Susan Buchser-

Lochocki, Eve Faulkes, D.D. Meighen, Sue Miles, and Sheila Rye read

to students in kindergarten to grade 6 on June 22nd and 23rd from books we purchased with funds from the FirstEnergy Foundation. For your reference, here is the list of books we used with the grade level:

K - *All Are Welcome* and *My Name is Yoon*; K/1 - *I Am Enough* and *Freedom Soup*; 1 - *Flat Stanley and Our School Garden*; 2 - *Black is a Rainbow Color* and *Chrysanthemum*; 3 - *She Persisted* and *A Friend for Henry*; 4 – *Henry’s Freedom Box* and *Stealing Home*; and 5/6 - *The Boy Who Harnessed the Wind* and *The Distance Between Us*. D.D. Meighen also donated some related books to the Shack.

Mike Attfield led our effort to organize this. Our partners at the Shack (Shawnda Cook, Devon McDaniel, and Dawn Lipscomb) ordered the books so that each child received a copy of the book read to him or her. Several of the volunteers met with Melissa Workman, director of the WVU Nursery School, to learn more about reading to children, and she shared many ideas to keep children engaged.

It is hard to know who had more fun from this experience. Shawnda said, “This was great, the kids LOVED the activities everyone planned! Thank you so much for partnering with us!”

Here are some comments from our readers:

**Nicole Bode:** “What a fun experience! Thanks for organizing.”

**Susan Buchser-Lochocki:** “This was alot of fun. We all talked about names and being friends.... friendly to each other.”

**Eve Faulkes:** “My reading session with *Henry’s Freedom Box* to the 4th grade went well. I could see some rapt attention to the end even though the book may have been created for younger readers. The words were simple, but the illustrations were wonderful. The book was about one of the most famous escapes to Freedom during the underground Railroad. One of the reasons I thought the book might not match today’s 9-year-olds was that one boy’s reaction to the slave boss was ‘that guy was a psychopath!’ After, we talked about how important is to be aware of unfairness and of people who are sad around you and might need help. Some of the kids brought up mass shootings and many talked about their fathers or grandfathers in the service. One talked about the nightmares and screaming of her uncle. They spoke of their own fears of loud noises and trauma that can be passed down from ancestors. It got pretty deep. We also

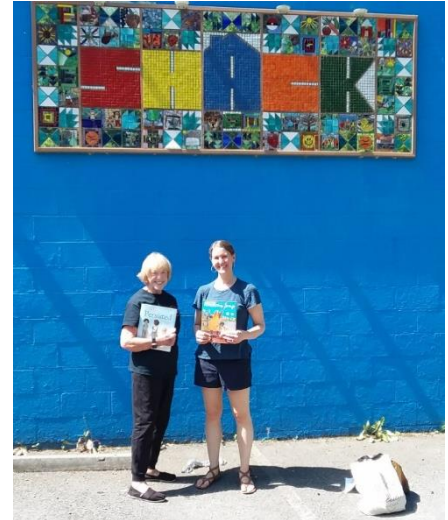
talked about when things go well and the history of successful helping one another across races and faith as happened at the Shack and in Scotts Run, a legacy of where they are playing and learning right now.”

**D. D. Meighen:** “Enjoyed the experiences as well. Reading with visual aids and creative dramatics is such a great way of telling or reading the story. With ‘Flat Stanley’ I had the kids become as flat as they could and slip through a coat hanger (all successful). Hope we might do this again.”

**Sheila Rye** planned an activity and made cornbread in a cast iron skillet because it’s mentioned in the book she read. She also gave the children two stickers from previous Martin Luther King, Jr., Day events that related to the theme of her book.

One of the readers shared that she/he was a dyslexic with learning disabilities but could still do lots of things like reading. After sharing that, one of the students said he/she also had dyslexia.

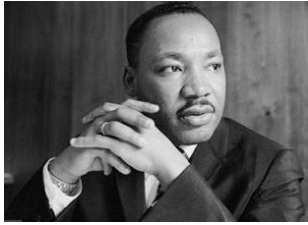

**MORGANTOWN CIVILIAN POLICE REVIEW AND ADVISORY BOARD UPDATE:** The Morgantown City Council will hold a public hearing on **Tuesday, July 5th**, during the council meeting that begins at 7:00 p.m. at City Hall, 389 Spruce Street. This will be on the revised ordinance creating a Civilian Police Review and Advisory Board. The revisions are necessary after Judge Susan Tucker signed the order finalizing the legal action with the Morgantown Fraternal Order of Police. Mike Attfield has contacted members of city council to express our support for the revised ordinance and our desire for council to appoint members to the board.

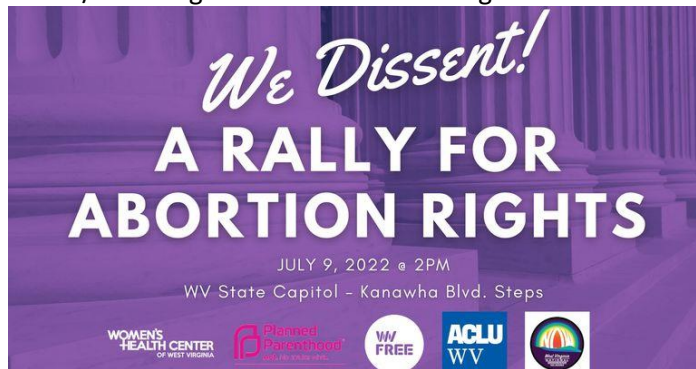

**ACLU AND ABORTION ACCESS:** “The American Civil Liberties Union (ACLU), ACLU of West Virginia (ACLU-WV), Mountain State Justice (MSJ) and the Cooley law firm filed the lawsuit in Kanawha County Circuit Court on Wednesday, June 29, 2022 on behalf of Women’s Health Center of West Virginia (WHC) and its staff.

“The statute in question, enacted by the state legislature in the late 1800s, not only criminalized the provision of abortion care, but was also used to punish the person seeking the abortion (and even their partners).

“The lawsuit argues the statute should be considered void under the doctrine of “repeal by implication,” a legal concept recognized in West Virginia courts that holds an older law is made void when a newer, conflicting law is passed.”
