City Council appointed Bronson Hurr to the Commission on January 2nd meeting and appointed Ashley Swanson to the Commission on February 6th.

Vacancies on Human Rights Commission. There are currently two vacancies on the commission. According to the City of Morgantown's website, "Appointments of to the Commission are made by City Council, and all must be residents of the City. All seats are non-ward specific. Upon formation in October 2012, terms are to be staggered: 4 shall serve two-year terms, 3 shall serve one-year terms in the first year. Thereafter, all terms will be staggered two-year terms. All new appointments and reappointments will need to be interviewed at the end of their term." National Women's History Month – Honors women as significant agents of change.

March 8: International Women's Day – Celebration of the economic, political, and social achievements of women worldwide. Recognition of need for empowering women to meet their health and family planning needs as central to realizing greater equality. With access to education, economic opportunity, and quality health care, healthier mothers can have healthier babies, economic gains, and help create less pressure on our planet's natural resources.

March 21: International Day for the Elimination of Racial Discrimination —Call to action to eliminate all forms of racial discrimination worldwide.





The Morgantown History Museum opened its Black History Exhibit on February 23rd. The exhibit will be open through May 2024 at 175 Kirk Street.

According to the City of Morgantown's press release, "The exhibit will contain four main galleries. The first exhibit, titled 'Settlement, Slavery and the Civil War reveals the lives of African Americans during the turbulent formative years of the county.

"The second gallery, 'Emancipation and Reconstruction' gives a voice to early African American entrepreneurs and other citizens through photos, artifacts and information. The third gallery, 'The Shape of Separate but Equal' shows the changes brought about in education for African Americans from elementary through graduate level, and tells the stories of some of the individuals involved in the process.

"The fourth and final gallery, 'Modern Figures,' showcases African American individuals who have been successful community leaders in their respective fields.

"The Black History Exhibit was created in cooperation with the Morgantown/Kingwood National Association for the Advancement of Colored People (NAACP) and the Scott's Run Museum.

"The Morgantown History Museum is currently open Wednesday- Friday 11:00 A.M. - 5:00 P.M. and Saturday- Sunday 12:00 P.M. - 6:00 P.M. The museum also closes for all state observed holidays.

Lulaine Childs is co-owner of New York City-based Street Team Productions, creating content for different platforms, including the Behind the Boards Podcast. Street Team distributes the short film "N'AP Boule" by Haitian filmmaker Alexandrine Benjamin and is currently working on a documentary on the 1974 Haiti World Cup team.

Filmmaker Lorna Tucker's "Amá" addresses the involuntary sterilization of thousands of Native American women at U.S. government-run hospitals, a practice that continued into the 1970s and included other women of color. Ms. Whitehorse is one of the Native women who experienced sterilization without consent and is a key figure in this moving documentary film. Jean Whitehorse will be on campus the second week in April, having classroom and faculty dialogues and engaging with Health Sciences graduate students. This is a rare opportunity for community members to learn directly from a Navajo Nation elder. The daughter of a Navajo code talker, Ms. Whitehorse attended government boarding schools, was part of the U.S. government's Indian Urban Relocation program, was active in the Civil Rights/Native Rights movement and Alcatraz Island occupation, and worked for New Mexico's Tribal Library Program for over 26 years before retiring. WVU Religious Studies Program and Humanities Center Public Talk by Dr. Donovan Schaefer on "Feeling Is Believing: A New Approach to Conspiracy Theory." This presentation will be Monday, March 4, at 4:30 p.m. in the Milano Room of the WVU Downtown Library. The talk will address "What makes people

believe? How do science and disinformation battle to convince us? And why has the apocalyptic discourse of conspiracy theory risen to prominence in our current political moment? This talk considers a new way of assessing the relationship between thinking and feeling, suggesting that we see them as deeply interrelated rather than fundamentally separate. Shifting our frame of reference allows us to draw a clearer map of how and why conspiracy theories have managed to gain such a powerful hold in contemporary society." Dr. Schaefer is an associate professor in the Department of Religious Studies at the University of Pennsylvania.

LEGISLATURE UPDATES/ALERTS

Everything changes so rapidly at the legislature that we can only alert you to bills that have been introduced that you might want to monitor. To do so, go to wvlegislature.gov, where you can find tabs for members of the House of Delegates and Senate and their contact information, committee members and agendas, and a "bill status" tab. Under the "bill status" tab, you can track an individual bill or set up a "bill tracking" account for all the bills you are tracking. Committee chairs set the agendas for their committees, so it is important to contact them to try to get a bill on – or kept off – the agenda.

There is only one more key date on the legislative calendar:

Sixtieth Day - March 9, 2024: Adjournment at Midnight.

There are several bills that were presented for discussion at the West Virginia Coalition for Truth in History meeting on January 28th. Bills that are still alive at "press time" are highlighted in yellow:

HB 4016: Prohibiting the delivery of unsolicited absentee ballot applications to any person who has not specifically requested one from the county clerk. This was referred to the House Judiciary Committee on the first day of the legislature, January 10th, and has not moved from that committee.

HB 4299: Permit teachers in K-12 schools be authorized to carry concealed firearms as a designated school protection officer. This bill has passed the House and is now in the Senate, where it is referred to the Senate Judiciary Committee and then to the Senate Finance Committee so it is still very much alive.

HB 4349: Establishing the Anti-Stereotyping Act. This was introduced to the House Education Committee on January 10th and has not moved there.

HB 4387: Relating to nondiscrimination at institutions of higher education. This was introduced to the House Education Committee on January 10th and has not moved there.

HB 4468: Establishing the Anti-Stereotyping Act. This was introduced to the House Education Committee on January 10th and has not moved there.

HB 4654: Removing bona fide schools, public libraries, and museums from the list of exemptions from criminal liability relating to distribution and display to minor of obscene

matter. This was referred to the House Judiciary Committee on January 12th. We thought this bill was dead, but it was revived and passed the House. It has been referred to the Senate Judiciary Committee. This is a particularly dangerous bill. As the West Virginia Association of Museums has noted, multiple people contribute to a museum exhibit so who would be charged with a felony?

HB 5036: Creating the Parents' Bill of Rights. This did not move out of its first House committee. The companion Parents' Bill of Rights (SB 505) was introduced on January 22nd and did not move out of the Senate Judiciary Committee. There is another similar bill (HB 4313) called the Parents' Bill of Rights that passed the House of Delegates on February 28th and was referred to the Senate.

HB 5227: Requiring age-appropriate instruction on the Holocaust. This was referred to the House Education Committee on January 26th with no further action to date. Delegate Evan Hansen is the lead sponsor on this bill. He worked with Senator Mike Oliverio, who introduced a companion bill – **SB 448:** Requiring age-appropriate instruction on Holocaust in public schools – in the Senate. That passed the first reading in the Senate Education Committee but was laid over and referred to the Senate Rules Committee on the second reading on January 25th.

SB 198: Prohibiting teaching of divisive acts and critical race theory in public schools. This was referred to the Senate Education Committee on January 10th and has not moved since then.

SB 273: Prohibiting certain divisive acts or concepts from schools, state agencies and any groups receiving state funding. This was referred to the senate Judiciary Committee on January 11th and has not moved since then.

SB 367: Anti-Racism Act of 2024. This was referred to the senate Judiciary Committee on January 12th and has not moved since then.

SB 870: Restoring Sanity Act. Senator Rucker introduced this bill on the last day to do so in the Senate. A committee substitute passed through the Education Committee and was then referred to the Senate Judiciary Committee on February 26th, where it died.

On February 28th, the House of Delegates passed **HB 5297: Relating to prohibiting pubertal modulation** and hormonal therapy when provided to assist in a gender transition on a vote of 88-11. According to Fairness West Virginia, this bill will "ban gender-affirming care for transgender adolescents.

"The bill, House Bill 5297, removes a very narrow exception in existing state code that allows transgender youth who are at risk of self-harm or suicide to continue receiving this care. The bill will now head to the Senate for consideration.

"'Let's be clear about what happened today'," said Andrew Schneider, Executive Director of Fairness West Virginia. "'Our delegates voted to strip parents of their ability to get the medically-necessary, lifesaving care that more than 550 health care providers in West Virginia support. They told parents with transgender teens who are at serious risk of self-harm or suicide that they can't get their kid the help that doctors say they need. I don't understand how anyone could look at these families and tell them their child's life doesn't matter, but that's what they did today with this vote." This bill now goes to the Senate.

SB 496: Prohibiting racial discrimination based on certain hair textures and hairstyles. This was the CROWN Act. It passed through the Senate Judiciary Committee and then was referred to the Senate Finance Committee, where it has died.

West Virginia NOW's Women's Bill of Rights:



The West Virginia NOW Facebook page, on January 30, noted that "Governor Justice and House Republicans are too busy fighting the culture war to care about the issues that really impact West Virginia's women and girls. To **call House Bill 5243** a 'Women's Bill of Rights' is a joke. The February CCSJ Update included a long list of bills that NOW said were needed for a "REAL Women's Bill of Rights." Almost none moved beyond being introduced in a committee. Only SB 496 made it to the Senate floor and then died when referred to the Senate Finance Committee as noted above.

The only other bill that moved was **HB4874**: **Relating to fatality and mortality review team**. This has passed the House and Senate but with amendments in the Senate so has to go back to the House to concur.

HB 5243: Relating to Women's Bill of Rights was passed by the House of Delegates on February 14 and referred to the Senate Judiciary committee. The Senate passed its version – SB 601: Creating WV Women's Bill of Rights – on February 28.

March: Women's History Month. March is Women's History Month, dedicated to recognizing and celebrating the contributions and achievements of women throughout history and in contemporary society. It's a time to reflect on the struggles for women's rights and to promote equality and recognition across various fields.

March 1: Zero Discrimination Day. Zero Discrimination Day calls for the elimination of all discrimination. Its goal is to promote both inclusivity and equality across the world. First initiated by the United Nations Programme on HIV/AIDS to address the stigma and discrimination faced by people living with HIV/AIDS. This day encourages all people to take a stand against it and serves as a reminder of why it's so important to create a world where everyone is treated with respect, regardless of their identity, their race, religion, and HIV status.

March 8: International Women's Day. This day originated in the early 20th century from labor movements in North America and Europe. Officially observed since 1911, the date commemorates the 1917 women's strike in Russia, which was pivotal in earning women the right to vote. This day globally celebrates women's achievements and advocates for gender equality.

March 10 – April 9: Ramadan. Ramadan is a sacred month of fasting, prayer, and reflection for Muslims worldwide. It commemorates the month in which the Quran was revealed to the Prophet Muhammad. Observers fast from dawn to sunset and engage in increased spiritual reflection and community activities. Date may vary based on moon sighting.

March 15: International Day to Combat Islamophobia. This global initiative hopes to address the prejudice and discrimination faced by Muslims worldwide. This day further advances the need to combat stereotypes and promote tolerance and acceptance. A more accepting world means that the rights and safety of Muslims are protected continuously.

March 18 – 24: Neurodiversity Celebration Week. This international event celebrates the wide range of diversity in the neurodivergent community including dyslexia, autism, and even ADHD, among others.

March 31: Easter. Easter celebrates the resurrection of Jesus Christ. It marks the culmination of the Passion of Christ and is preceded by Lent, a 40-day period of fasting and penance.

March 31: International Transgender Day of Visibility. Dedicated to celebrating transgender people, it hopes to eradicate discrimination faced by the community worldwide. It was first founded by a U.S.-based transgender activist Rachel Crandall of Michigan in 2009. She was frustrated that the only well-known day focused on the community was Transgender Day of Remembrance, which mourns the murders of transgender people across the world instead of celebrating those living as transgender.
