MARTIN LUTHER KING JR. DAY RECAP: Thank you to all who attended. If you missed the event or want to watch it again, it is on YouTube at <https://youtu.be/HuCJxvkcoGk>. This year's theme was "Lift Every Voice and Vote!" Barb Howe presented "The Road to the Vote," chronicling voting rights from 1776 to 1990 and the Americans with Disabilities Act. She also provided information about deadlines and ballot

choices for the May primary, with assistance from Alee Robins, voter services manager at the Monongalia County Clerk's Office. Jessica Nelson represented the League of Women Voters-Morgantown/Monongalia County with information about voting access for individuals in long-term care facilities, caretakers, and students, including an emphasis on absentee voting. This is a big but little-known issue affecting hundreds of voters in Monongalia County and thousands throughout West Virginia. Delegate Anitra Hamilton, past president of the Morgantown - Kingwood Branch of the NAACP, represented the branch and focused on the importance of voting because every vote counts as it impacts our communities and our state.

Executive committee member of Fair Districts PA (FDPA), Tony Crocamo, discussed "Lobby Legislators on Any Issue: A Non-confrontational, Team-approach to Citizen Advocacy." Morgantown musicians Chris Haddox and the Osage Soul & Gospel Choir featuring Al Anderson and Aristotle Jones provided the music. In addition, Al's solo is a tradition of our programs.

LEAGUE OF WOMEN VOTERS OF MORGANTOWN-MONONGALIA COUNTY (LWV-MM). Thanks to Cynthia Nelson, the secretary of the LWV-MM, for this report:

The WV Legislature is in session. Our LWV-WV LLAW team is watching attentively and will be alerting citizens to be aware of bills introduced that are in opposition to, or in support of League priorities. Please watch our “Make Some Noise” campaign alerts in your email if you are a member, <https://lwvww.org/category/league-of-women-votes-of-wv/action-alerts/>, or on League of Women Voters of West Virginia facebook page. When legislation is introduced that impacts your concerns, the best time to contact your representative is immediately.

The League of Women Voters of the United States issued the following statement in response to the continued escalation of federal military activity in Minnesota from federal immigration officials: “The League of Women Voters condemns the escalating actions by US Immigration and Customs Enforcement (ICE) that put people at risk, deny individuals their constitutional rights, and undermine the democratic values meant to protect us all.

“We are horrified by federal immigration enforcement operations that deliberately infringe upon First Amendment rights to assemble and dissent. The use of intimidation, surveillance, and deadly force against lawful protestors is not public safety—it is repression. The use of lethal force against people exercising their constitutional rights is unacceptable and must be fully investigated. These fatalities, followed by false narratives designed to obscure the truth and impede oversight, represent a historic abuse of power we’ve never seen as a country. Democracy cannot endure when its government uses violence to silence dissent and evade accountability.

“The League of Women Voters reaffirms that the rights outlined in the Constitution belong to all people, without exception. We will not accept policies or practices that suppress civic participation, weaponize enforcement, or undermine fundamental rights and human dignity.”

With the candidate filing deadline of January 31, 2026, our Vote 411 team is springing into action to upload candidate information and obtain candidate profile information from each candidate. If a candidate in your district is not providing the information requested to inform voters of their priorities, then feel free to ask them why they are not participating in the important voter education resource. You do not have to be a League member to use vote411.org.



The branch has a Readings on Race and Rights group and does its work with a variety of committees, including Education, Political Action, Legal Redress, Criminal Justice, and Health.




Souper Bowl Food Drive




